III. NCATE Update

Dr. Bower gave the update. The NCATE visit is scheduled for November 6-10, 2010.

1. The Steering Committee is working on the report to address the various standards. A draft will be done in early Spring and the final report will be done by the end of the Spring semester.
2. Information will be provided to help everyone know what the expectations will be for the NCATE visit. College-level meetings will be held to address college-specific issues. Department-level meetings will be held to address department-specific issues.
3. The NCATE website is being revamped.
4. The Unit Assessment Committee has been reconfigured. Patty Poulter is the chairperson. Their main focus will be to review the Unit Assessment document and make any necessary revisions. They will also offer training on using the rubrics.

IV. Illinois Teacher Certification Board Update

Dr. Bower gave the update.

1. The Board is looking at how to better incorporate reading, special education, English language learners, and gifted education into the Illinois teaching standards. An advisory committee has been created to review the standards to place greater focus on differentiated instruction.
2. The Middle School endorsement will be addressed this Fall. They are looking at how to incorporate the middle-school standards into the endorsement. There is a big push to raise the requirement to 24 semester hours in the subject area.
