V. Teacher Education Update/Executive Director's Report

Dean Jackman and Dr. Bower shared a joint letter from the IBHE and ISBE regarding a statute change that became effective July 1, 2012, requiring the APT or any other exit exam to be completed prior to degree completion. A copy of this letter can be found on the COTE website. Institutions are being allowed to develop policies to allow for degree completion to be posted to transcripts for students who have not yet passed the APT Test. The Council agreed that Dean Jackman should develop an executive action proposal to address this issue.

VI. Program Analysis Steering Committee Update

The steering committee is currently refining the template and has a May 2013 deadline to have the template finalized. Feedback from department chairs will be due the middle of September.
